### Applicable Products

B4ST, Soy 30, SoyFx SC, and PhenomST and all NewFields Ag-branded products purchased during the 2024-2025 purchase period (12/01/24 – 07/01/25) and applied to seed via treater application, applied at planting via Planter-box or applied In-furrow.

### Eligible Participants

NewFields Ag resellers, farmers, and custom seed treatment applicators that purchase case quantities of the applicable products directly and 1. Apply them on seed, either alone or in combination with other seed treatment products or 2. Apply them through the Planter-box or In-furrow.

### Conditions of the Program

- Seeds originally treated with the above applicable products will receive 50%-of-invoice replacement credit in the form of new product to treat seeds used to replant acres destroyed due to reduced stands from flooding, hail, or other weather-related problems.
- The decision to replant must be due to weather-related issues, not grower or contractor error in performing field work, such as herbicide spraying. Application of products not on an applied label, miscalculation in application, sprayer contamination, and all other errors are not covered under this Replant Program.
- Replanting must be completed within recommended guidelines for planting season for the variety being replanted. The source of guidelines will be seed company variety guides and specifications for the seed variety used for replanting. As a rule, no credit for replant will be given for seed planted after July 28, 2025.
- Seed variety choice will be at the discretion of the grower or recommendation from a seed company representative or a retail location servicing the grower.
- This program does not apply to double crop soybean plantings; that is, soybeans planted after the harvest of winter wheat or any other crop.
- The Replant Program does not have a limit or cap on applicable products, but NewFields Ag reserves the right to limit the volume of acres used for replant to 30% of total account acres.
- The Replant Program may be limited due to lack of applicable product inventory and NewFields Ag accepts no liability for this program due to its inability to supply the applicable products. Inability to supply the applicable products to the level of replant will constitute no future value or credit.
- NewFields Ag reserves the right to substitute other products if the applicable product is unavailable.
- There is no cash value with this Replant Program.
- Copies of the original invoice(s), replant invoice(s) and reseller invoice (for applicable products) must be included with the Replant Claim Form. Failure to include the appropriate documentation will disqualify you from the benefit of the Replant Program.
- All claims must be submitted by July 28, 2025, to be eligible for reimbursement and must not exceed original purchase. No Exceptions.

### Filing Claim Process

1. Reseller location (the selling outlet who would service the grower) submits NewFields Ag Replant Claim Form to NewFields Ag along with invoice(s) from NewFields Ag Distributor for cases of applicable products used for the original planting accompanied by the receipts for the replant seed, treatments, and seed treatment products.
2. This documentation may be submitted through reseller to a NewFields Ag Sales Representative, or by submitting it by email directly to NewFields Ag's home office in Grand Mound, Iowa at [info@newfieldsag.com](mailto:info@newfieldsag.com). Credit will be issued by NewFields Ag to be passed to the submitting reseller. The expectation of NewFields Ag is to credit the reseller as if it were cases returned.
