## DIRECTIONS FOR USE

### FOLIAR APPLICATION:

1. Measure using the included measuring scoop in the Carry-R Foliar powder bag.
2. Preslurry Carry-R Foliar with water before introducing into the tank mix. Batch mixing is recommended.
3. Add to tank mix and top off with water carrier. It's vital to continue agitation throughout the tank-mixing process and allow enough time for recirculation between additions of each separate product. Failure to add products one at a time, lack of sufficient water during mixing or insufficient agitation can result in product separation. Applicators should continue agitation throughout application to keep all ingredients suspended.

Read the entire front and back label before using this product. Use only according to label directions. To the extent consistent with applicable law, this product shall not be reverse engineered or used by Buyer for research purposes.

### RATE:

Use 2 oz. of product per acre. Add dry product with tank mix and top off with water carrier. Suggest 10-20 gallons per acre of spray mix through a ground sprayer or 2-4 gallons per acre of spray mix through a plane or helicopter. For drone applications, use 1-3 gallons per acre of spray mix. Jar test for compatibility

### HANDLING

Avoid contact with skin, eyes and clothing. Avoid inhalation of powder. Wash any contamination from skin or eyes immediately. Wash hands and exposed skin before eating, drinking, smoking or using the toilet.

### STORAGE

Store in tightly closed original container in a dry, cool and well-ventilated place. Do not exceed 80°F for extended periods. Keep container closed when not in use. Keep away from food, drink and animal feedstuffs.

### EXPIRATION DATE

Two years from date of production. See container for production date.

### DISPOSAL

Dispose of contents/container in accordance with local/regional national/international regulations.
