

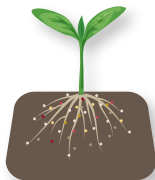


## FOR ALL CROPS: Innovation in the Planter Box

### PLANTER BOX/HOPPER BOX APPLICATION:

The recommended application rate is 0.5 oz. (14 g) per 1 unit of corn (80,000 seeds/unit) or soybeans (140,000 seeds/unit). For wheat and other small seed crops 0.5 oz (14 g) per 50 lbs (22.67 kg) of seed. Apply by dispersing the powder evenly onto seed using appropriate equipment. (See additional instructions as needed.)

No additional specific markers or distinguishing features of seed coating are needed.
