The recommended application rate is 0.5 oz (14 g) per 50,000 sorghum seeds. Apply by dispersing the powder evenly onto seed using appropriate equipment.

Provid-R PM Corn can be applied in all planter types.

No additional specific markers or distinguishing features of seed coating are needed.
